# Statement of Licensing Policy for Hackney Carriages, Private Hire Vehicles, Drivers and Private Hire Vehicle Operators Consultation 2015

The policy the Council is reviewing affects both Hackney and Private Hire licence holders and their customers (you). Though both Hackney Carriage and Private Hire vehicles go through similar additional testing for safety and comfort, they are controlled by separate regulations and requirements. This does mean we need to ask you separately about your views and experience with each trade. To assist consultees we have provided some descriptions and back ground information on both of these trades.

#### Background information about types of vehicles

#### **Hackney Carriage Vehicles**

There are 352 Hackney Carriage vehicles in the Cheshire West and Chester district

Generally known as Taxis (they have a "Taxi" sign on the roof), these vehicles are available for immediate hire. They can be hired by being hailed in the street or from a designated rank often in busy locations such as train stations or town centres. Hackney Carriages can also be pre booked in advance. In Cheshire West and Chester Hackney Carriages operate in three zones: Chester, Ellesmere Port and Neston and Vale Royal. About 90% of Hackney Carriages are Wheelchair Accessible Vehicles (WAVs) (100% Chester, 100% Ellesmere Port and Neston and 79% in Vale Royal). These WAV vehicles have been permanently adapted/modified to enable a passenger using a standard wheelchair to enter, exit and travel safely and securely whilst always remaining in their wheelchair for the entire journey. The majority of these vehicles can carry 6 or more passengers and have other aids to improve accessibility such as additional steps, contrasting colour grab handles and seat flashes and fitted hearing loops.

Legislation allows the Council to determine and restrict what type of vehicle it will license as a Hackney Carriage.

#### **Private Hire Vehicles**

There are 939 private hire vehicles in the Cheshire West and Chester district.

These vehicles can only be booked in advance through a licensed Private Hire Operator. They cannot be hailed in the street or booked via the driver. About 5% of private hire vehicles are wheelchair accessible (WAVs). The fleet is predominantly four door saloon vehicles with some people carriers and mini buses. Private Hire vehicles have no restrictions in the areas they can operate within the West and Chester District.

Though subject to some general conditions, the legislation does not allow the Council to determine what type of vehicle is used or if it is required to be wheelchair accessible.
