**The Acorns Primary and Nursery School
Increase in Age Range Consultation**

To Pupils, Parents/Carers, Staff, Governors and Stakeholders

6 March 2017

Cheshire West and Chester Borough Council is proposing to permanently increase the age range of The Acorns Primary and Nursery School Pooltown Road, Whitby, Ellesmere Port, CH65 7ED from 3-11 years of age to 2-11 years of age from September 2017.

1. Why we are proposing to increase the age range of The Acorns Primary and Nursery School

Cheshire West and Chester Borough Council (the Council) have been requested by the Governing Body of The Acorns Primary and Nursery School (the Governing Body) to permanently increase the age range of the school to include provision for two year-olds. The Governing Body's request follows an Ofsted judgement that Heathfield Playgroup, which currently provides provision for two year-olds from the school, 'requires improvement'. The Governing Body believe that it is now best placed to ensure a high quality Early Years offer for the most vulnerable two year-olds is available to local families through building on the strengths of its existing Early Years leadership team.

2. Where will the provision be made?

The school propose to make use of the accommodation currently used by Heathfield Playgroup to provide the Early Years offer to two year-olds. This would now be provided under the school's governance. Heathfield Playgroup is aware of this proposal.

3. Will any building work be required to accommodate the younger children?

The school believe that no major works will be required to the current premises. Any adaptations will be minimal and if required will be carried out during the summer holidays.

4. How many pre-school children will be admitted and will this mean reducing the number of pupils admitted to the school as a consequence?

The Governing Body propose to admit up to 20 two year-olds for a session running from 8.45am to 11.45am each day. The Governing Body will review demand with a view to the potential future introduction of additional afternoon sessions. The Governing Body believe that there is adequate space within the school for them to admit up to the Published Admission Number of 45 pupils in each year group. The school propose to employ existing Heathfield Playgroup employees along with a new Room Leader to staff the provision for two year-olds.

5. The consultation process – indicative timeline

Date	Activity
6 March – 2 April 2017	Informal Public Consultation Period
14 March 2017 3pm to 6pm	Drop-in Meeting at the school for parents/carers, staff, governors & stakeholders
April 2017	The Director of Education decides whether to continue with the proposal. If so, a Public Notice will be published in a local newspaper, displayed at the school and published on the Council's website. During this time comments and objections can be made about the proposal. The Public Notice will run for four weeks.
June 2017	The Cabinet Member for Children and Young People considers all responses made and decides whether to approve the proposal.
Anticipated September 2017	Permanent increase in age range of the school is implemented if the proposal is agreed.

6. How can I give my views?

There are a number of ways to give us your views on this proposal:

- At a drop-in for parents/carers, members of staff and governors is being held at the school on 14 March 3pm to 6pm, where there will be the opportunity to ask questions and complete a response form.

7. What happens next?

This consultation stage closes on midnight 2 April 2017. A report summarising the responses received during the consultation period will be submitted to the Director of Education who will then decide whether to proceed with the proposal and move to publish statutory proposals in the form of a public notice. The public notice would be published in a local newspaper. For a period of four weeks following the publication date any person can comment on the proposals. Having taken into account any responses, the Cabinet Member for Children and Young People will then take a final decision as to whether to proceed with the proposal.
